REACH and RoHS III Compliance

Dear Customer,

The European regulation (EC) 1907/2006 concerning Registration, Evaluation, Authorization and restriction of the Chemical substances (**REACH**) is in force since June 2007.

This new legislation has the aim to evaluate and control the risks due to chemical substances. Its purpose is to improve the protection of human health and the environment through a better and earlier identification of the chemical substances properties.

UFI FILTERS HYDRAULIC DIVISION is aware of the conditions raised by the new REACH legislation relating to the products that supplies or may supply to its customers. In particular, with regard to the articles, the only requirements of REACH are:

1. In case of intentional release of substances from the articles, a record of these substances must be kept (if produced or imported > 1 ton / year)
2. If SVHC1 substances are contained at a higher level than 0.1%, the presence of such substances must be notified to the Agency and to the customer.

None of the articles that we supply to you has an intentional release of substances in normal use or reasonably foreseeable (Article 7), consequently this condition does not apply to our products.

Concerning the substances contained in our articles, we can confirm that based on our knowledge and the declarations of our suppliers to date, none of the substances listed in the candidate list (Annex XIV of the Regulation) is present in our products in quantity exceeding 0.1%.

We declare that we will provide communication to our customers in the event that any article contains substances included in the candidate list (updated regularly) within 45 days from its publication (art. 33), otherwise we will not send any communication.

Based on the declarations received from our suppliers, we also guarantee that the products we supply, if subject to the requirements of the European Directive 2011/65 / EU and EU 863/2015 on the restriction the use of certain dangerous substances in electrical and electronic equipment (**RoHS III**), are compliant with it.
